

Viela VIPs Co-Pay Assistance Program

The Viela VIPs Co-Pay Assistance Program helps eligible individuals who are prescribed treatment with a medicine from Viela Bio. The program helps with drug-related out-of-pocket expenses such as co-pays and co-insurance.

How to Get Started

Step 1 Complete the Patient Referral Form to enroll in Viela VIPs.

If you have commercial insurance, your Case Manager will automatically refer you to the Co-Pay Assistance Program after your benefits investigation.

Step 2 Your eligibility for co-pay assistance will be verified.

If eligible, you will be automatically enrolled in the program.

Step 3 You're enrolled in the Co-Pay Assistance Program.

Your Case Manager will notify you and your doctor. You will not receive a co-pay card, but your doctor or the specialty pharmacy will receive a confirmation letter with instructions on how to submit claims for reimbursement. Your enrollment in the program is effective from the date of approval through the end of the calendar year. As long as you are commercially approved for treatment, you will be automatically re-enrolled each calendar year for continued co-pay assistance.

Once enrolled, the Co-Pay Assistance Program will cover 100% of eligible out-of-pocket expenses up to the program maximum.

Viela VIPs reserves the right to make eligibility determinations, to establish program benefit maximums, and to modify or discontinue the program at any time. This program assists individuals with their out-of-pocket drug costs only and not the cost of infusions, medical appointments, testing, or other related services.

Viela VIPs Co-Pay Assistance Program

Program Eligibility

Eligible If:

- Prescribed treatment for the FDA-approved indication only
- Commercially insured
- Resident of the U.S. or U.S. territories
- Under the care of a licensed U.S. or U.S. territory physician
- Payer approval for the treatment

Not Eligible If:

- Prescribed treatment for anything other than the FDA-approved indication
- Enrolled in federal or state healthcare programs including Medicare, Medicaid, TRICARE, DoD, or any state medical or pharmaceutical assistance program
- Insurance pays the entire cost of the prescription
- Prohibited by law, taxed, or restricted*

**Check with your Case Manager to determine if your state allows co-pay assistance programs*

Contact your Viela VIPs Case Manager if you have any questions about your eligibility. If you are not eligible for the Co-Pay Assistance Program and need help with your out-of-pocket expenses, your Case Manager is available to help review your coverage options and refer you to other financial assistance programs that may offer support for eligible patients.
